RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE AFFIDAVIT OF UNDERTAKING AS REPRESENTATIVE OF GOVERNOR ALFREDO G. MARAÑON, JR., RELATIVE TO THE DONATION OF ONE (1) UNIT AMBULANCE FROM TOKYO METROPOLITAN GOVERNMENT THROUGH MRS. ELEANOR A. FUKUDA IN FAVOR OF THE CITY OF BAGO THROUGH THE PROVINCE OF NEGROS OCCIDENTAL AS DONEE/CONSIGNEE OF THE AMBULANCE.

WHEREAS, in his letter dated March 14, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City Government of Bago in the Affidavit of Undertaking as representative of Governor Alfredo G. Marañon, Jr., relative to the donation of one (1) unit ambulance from Tokyo Metropolitan Government through Mrs. Eleanor A. Fukuda in favor of the City of Bago through the Province of Negros Occidental as Donee/Consignee of the ambulance;
