**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY OF BAGO AND PHILIPPINE CROP INSURANCE CORPORATION FOR THE IMPLEMENTATION OF THE PROJECT ENTITLED: "PROPOSAL FOR THE PROVISION OF CROP INSURANCE COVERAGE FOR THE FARMERS OF THE CITY OF BAGO THROUGH THE FARM PROTECTION CAPITAL FUND OR PREMIUM SUBSIDY SCHEME".**
