RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF SERVICES TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND MAGIC DISCO SOUND SYSTEM FOR PROVIDING THE CITY FOUR SETS OF LIVE BANDS AT BANTAYAN PARK IN CONNECTION WITH THE HOSTING OF THE CITY OF THE 31ST NATIONAL FOLK DANCE WORKSHOP FOR TEACHERS ON MAY 16-20, 2011.

WHEREAS, in his letter dated May 10, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in the Contract of Services to be executed by and between the City Government of Bago and Magic Disco Sound System for providing the City four sets of Live Bands at Bantayan Park in connection with the hosting of the City of the 31st National Folk Dance Workshop for Teachers on May 16-20, 2011;
