RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT IN THE IMPLEMENTATION OF SOCIAL PENSION FOR THE INDIGENT SENIOR CITIZENS IN THE CITY AS PROVIDED FOR UNDER REPUBLIC ACT NO. 9994 ALSO KNOWN AS THE EXPANDED SENIOR CITIZENS ACT OF 2010.

WHEREAS, in his letter dated May 10, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Department of Social Welfare and Development in the implementation of Social Pension for the indigent Senior Citizens in the City as provided for under Republic Act No. 9994 also known as the Expanded Senior Citizens Act of 2010;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
