RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BARANGAY POBLACION FOR THE IMPLEMENTATION OF LIVELIHOOD DEVELOPMENT ASSISTANCE PROGRAM THAT WILL PROVIDE ADDITIONAL/ALTERNATIVE LIVELIHOOD OPPORTUNITIES THAT WILL HELP UPLIFT THE STANDARD OF LIVING OF THE RESIDENTS IN THE BARANGAY.
