LEONILO DEL CARMEN TO PRACTICE HIS PROFESSION FOR A FEE AS GENERAL SURGEON AT BAGO CITY HOSPITAL IN COORDINATION WITH THE MEDICAL OFFICERS OF THE HOSPITAL.
