WHEREAS, Mr. Gabriel L. Bongco wanted to donate Subdivision Road Lots located at San Gabriel Subdivision Phases I and II in Barangay Balingasag, Bago City, consisting of 30 parcel of land;

WHEREAS, as per ocular inspection of the site by the City Engineer's, it was observed that the Eight (8) Road Lots, namely; Lot 24, 25, 26, 30, 31, 32, 33 and 34 are still undeveloped areas, thus, only 22 existing road lots have been recommended by the City Engineer's Office for acceptance by the city;
