RESOLUTION URGING CERTAIN LOCAL GOVERNMENT UNIT (LGU) DEPARTMENTS PARTICULARLY THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), TREASURER'S OFFICE AND CITY HEALTH DEPARTMENT TO CONDUCT INSPECTION OF ALL DORMITORIES AND BOARDING HOUSES IN BAGO CITY AND TO CONFIRM THEIR COMPLIANCE OF LEGAL REQUIREMENTS AND TO FURNISH COPY OF RESULTS OF SUCH INSPECTION IN AID OF LEGISLATION TO ENSURE SAFETY OF THE STUDENTS.

WHEREAS, boarding houses serve as temporary abodes of students during the school term and as such should be safe and comfortable for boarding students;

WHEREAS, business permits for boarding houses are issued by the Local Government Unit (LGU) to ensure compliance with legal requirements in order to protect the interest of the City, the students, and their parents;

NOW, THEREFORE, upon motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Ruben T. Torres, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to urge certain Local Government Unit (LGU) departments particularly the Department of Social Welfare and Development (DSWD), Treasurer's Office and City Health Department to conduct inspection of all dormitories and boarding houses in Bago City and to confirm their compliance of legal requirements and to furnish copy of results of such inspection in aid of legislation to ensure safety of the students.
