LA SALLE FOR THE AFFILIATION AND TRAINING OF MEDICAL STUDENTS, SUBJECT TO THE POLICIES, PROCEDURES AND GUIDELINES GOVERNING AFFILIATION AND TRAINING OF STUDENTS IN THE DEPARTMENT OF HEALTH/HOSPITAL/RURAL HEALTH UNITS AND OTHER HEALTH AGENCIES.**
