RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CITY OF BAGO FOR THE GRANT FROM THE DEPARTMENT OF HEALTH THROUGH THE PROVINCIAL GOVERNMENT TO BE UTILIZED IN THE DELIVERY OF AN EFFECTIVE INTEGRATED HEALTH CARE FOR MATERNAL NEONATAL CHILD HEALTH AND NUTRITION PROGRAM OF THE CITY.

WHEREAS, in his letter dated August 2, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the Province of Negros Occidental and the City of Bago for the grant from the Department of Health through the provincial Government to be utilized in the delivery of an effective integrated health care for Maternal Neonatal Child Health and Nutrition Program of the City;
