RESOLUTION NO. 11-292

RESOLUTION APPROVING THE REQUEST OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-4TH SUB-DISTRICT ENGINEERING OFFICE FOR A LOT OWNED BY THE CITY OF BAGO, TO THE EXTENT OF NOT MORE THAN FIVE THOUSAND SQUARE METERS ONLY, SITE ADJACENT TO THE BAGO CITY ECO PARK BESIDE THE NATIONAL HIGHWAY TO BE USED FOR THE CONSTRUCTION OF THEIR NEW OFFICE BUILDINGS AND FACILITIES.

WHEREAS, in a letter dated July 25, 2011, the Department of Public Works and Highways-4th Sub-District Engineering Office represented by Mr. Emmanuel C. Mendiguarin, OIC-District Engineer, withdraw their previous request for a lot which their office compound is presently situated, and in turn, hereby request for the site adjacent to the Bago City Eco Park beside the national highway containing an area of 7,000 sq. meters or more where their new office buildings and facilities will be constructed;

WHEREAS, after a though deliberation on the matter, the Committees on Laws and Government Assets recommends that not more than 5,000 sq. meters be granted to the request of the DPWH-4th Sub-District Engineering Office;

NOW, THEREFORE, upon motion of SP Member Allan C. Galunan, duly seconded by SP Member Ruben T. Torres, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to approve the request of the DPWH-4th Sub-District Engineering Office for a lot owned by the City of Bago, to the extent of not more than Five Thousand Square Meters, site adjacent to the Bago City Eco Park beside the national highway to be used for the construction of their new office buildings and facilities.
