RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT AND THE CITY GOVERNMENT OF BAGO FOR THE ESTABLISHMENT OF A DATABASE ON FILIPINOS THROUGH ITS NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR) IN A MANDATE TO CONTRIBUTE TO POVERTY ALLEVIATION AND EMPOWERMENT OF ITS CONSTITUENTS THROUGH PROGRAM AND SERVICES.

WHEREAS, in his letter dated August 9, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the Department of Social Welfare and Development and the City Government of Bago for the establishment of a database on Filipinos through its National Household Targeting System for Poverty Reduction (NHTS-PR) in a mandate to contribute to poverty alleviation and empowerment of its constituents through program and services;
