RESOLUTION NO. 11-297

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE NATIONAL STATISTICS OFFICE – OFFICE OF THE CIVIL REGISTRAR GENERAL AND THE CITY GOVERNMENT OF BAGO FOR PROVIDING A SOFTWARE KNOWN AS THE PHILIPPINE CIVIL REGISTRY INFORMATION SYSTEM (PhilCRIS) TO BE USED BY THE LOCAL CIVIL REGISTRAR'S OFFICE.

WHEREAS, in his letter dated August 9, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the National Statistics Office – Office of the Civil Registrar General and the City Government of Bago for providing a software known as the Philippine Civil Registry Information System (PhilCRIS) to be used by the Local Civil Registrar's Office;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;

NOW, THEREFORE, upon motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Ruben T. Torres, the Sangguniang Panlungsod
