WHEREAS, in an endorsement letter dated July 20, 2011 from the Honorable City Mayor, respectfully referred to the Honorable Members, Sangguniang Panlungsod, this City, communication from Mrs. Letecia S. Ledesma, offering to sell her property located at Barangay Tabunan, this City, to the City of Bago;

WHEREAS, a survey was conducted by the City Engineer and it was found out that the lot is indeed owned by Mrs. Letecia S. Ledesma and there is an existing day care center located thereat;
