RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL FOR A FINANCIAL ASSISTANCE FOR THE SPORTS EVENT IN THE 45TH CHARTER ANNIVERSARY OF THE CITY.

WHEREAS, in his letter dated August 31, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in the Project Proposal and Memorandum of Agreement to be executed by and between the City Government of Bago and Provincial Government of Negros Occidental for a Financial Assistance for the Sports Event in the 45th Charter Anniversary of the City;
