**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL FOR A FINANCIAL ASSISTANCE FOR THE SPORTS EVENT IN THE 45<sup>TH</sup> CHARTER ANNIVERSARY OF THE CITY.**
