RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, VILLANUEVA CLINICAL LABORATORY & POLYCLINIC AND THE NEW BLOOD CHANNEL AS AN ACCREDITED LICENSED CLINICAL LABORATORIES TO CATER THE REQUEST FOR LABORATORY TESTS/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENT FOR THE RENEWAL OF THE LICENSE OF BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.

WHEREAS, in his letter dated September 13, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the City Government of Bago, Villanueva Clinical Laboratory & Polyclinic and The New Blood Channel as an accredited Licensed Clinical Laboratories to cater the request for laboratory tests/examinations which are not available at the Bago City Hospital Laboratory as a requirement for the renewal of the license of Bago City Hospital with the Department of Health;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
