**RESOLUTION NO. 11-323**

**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, VILLANUEVA CLINICAL LABORATORY & POLYCLINIC AND THE NEW BLOOD CHANNEL AS AN ACCREDITED LICENSED CLINICAL LABORATORIES TO CATER THE REQUEST FOR LABORATORY TESTS/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENT FOR THE RENEWAL OF THE LICENSE OF BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.**

**WHEREAS**, in his letter dated September 13, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the City Government of Bago, Villanueva Clinical Laboratory & Polyclinic and The New Blood Channel as an accredited Licensed Clinical Laboratories to cater the request for laboratory tests/examinations which are not available at the Bago City Hospital Laboratory as a requirement for the renewal of the license of Bago City Hospital with the Department of Health;

**WHEREAS**, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
