**RESOLUTION NO. 11-331**

**RESOLUTION AMENDING RESOLUTION NO. 11-303 TO READ AS FOLLOWS: RESOLUTION AUTHORIZING THE CITY TREASURER TO OPEN AN ACCOUNT WITH LAND BANK OF THE PHILIPPINES-BACOLOD BRANCH AND THE TRANSFER OF THE AMOUNT OF PhP 700,000.00 FROM THE GENERAL FUND (2011 20% IRA DEVELOPMENT FUND FOR ENVIRONMENT, PARTICULARLY FOR THE ENVIRONMENTAL MANAGEMENT PROGRAM) TO THE TRUST FUND AS INITIAL DEPOSIT AND OUR COUNTERPART FUND FOR THE IMPLEMENTATION OF THE NPS-ENRMP BAGO RIVER WATERSHED FOREST RESERVE REHABILITATION PROJECT.**

**WHEREAS**, in his letter dated October 3, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, amending Resolution No. 11-303 which authorized our City Treasurer to open account with Maybank-Bago Branch for the Bago River Watershed Rehabilitation Project;

**WHEREAS**, upon submission of said documents to Municipal Development Fund Office which handles the release of World Bank GEF Fund, they suggested to open said account in a government bank to avoid payment of fees which private banks usually charges on like transactions that will be subsequently deducted to the amount that will be downloaded to the City for the Project;

**WHEREAS**, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;

**NOW, THEREFORE**, upon motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Loreto N. Cauntoy, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved, to amend Resolution No. 11-303 to read as follows: Resolution authorizing the City Treasurer to open an account with Land Bank of the Philippines-Bacolod Branch and the transfer of the amount of PhP 700,000.00 from the General Fund (2011 20% IRA Development Fund for Environment, particularly for the Environmental Management Program) to the Trust Fund as initial deposit and our counterpart fund for the implementation of the NPS-ENRMP Bago River Watershed Forest Reserve Rehabilitation Project.
