**RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO INCUR OBLIGATIONS CHARGEABLE AGAINST THE LUMP SUM APPROPRIATION FOR CAPITAL EXPENDITURES AND MAINTENANCE AND OTHER OPERATING EXPENDITURES FOR CALENDAR YEAR 2012 AND AUTHORIZING THE SAME TO ENTER INTO CONTRACT TO THE LOWEST CALCULATED RESPONSIVE BIDS, AS MANDATED UNDER MEMORANDUM NO. 2010-014 OF THE COMMISSION ON AUDIT.**

**WHEREAS**, in his letter dated November 3, 2011, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, granting him the authority to incur obligations chargeable against the lumpsum appropriation for capital expenditures and maintenance and other operating expenditures for Calendar Year 2012 and authorizing the same to enter into contract to the lowest calculated responsive bids, as mandated under Memorandum No. 2010-014 of the Commission on Audit;

**WHEREAS**, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
