RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE CITY GOVERNMENT OF BAGO FOR THE IMPLEMENTATION OF THE SLRF PROJECT UNDER CY 2008; CONCRETE REBLOCKING AND PAVEMENT MARKING OF BAGO-NAPOLES-MALINGIN-SAN JUAN DEL MONTE ROAD, BRGYS. LAG-ASAN AND NAPOLES WITH AN ALLOCATION OF ONE MILLION EIGHT HUNDRED TEN THOUSAND THREE HUNDRED FIFTY PESOS AND FIFTY SEVEN CENTAVOS (P 1,810,350.57);

WHEREAS, in an Indorsement letter dated November 15, 2011, from the Honorable City Mayor, respectfully referred to the Honorable Members Sangguniang Panlungsod, this City, the self explanatory communication from Engr. Joenil B.
