RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PHILIPPINE CARABAO CENTER (PCC) AND THE CITY GOVERNMENT OF BAGO FOR A PARTNERSHIP AND IMPLEMENTATION THRU THE PCC'S BANNER PROGRAMS AS GENETIC IMPROVEMENT PROGRAM (ARTIFICIAL INSEMINATION, BULL LOAN PROGRAM), CARABAO-BASED DAIRY ENTERPRISE DEVELOPMENT AND TECHNICAL ASSISTANCE.
