RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES OF THE CITY MAYOR'S OFFICE, THE AMOUNT OF ONE HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED PESOS AND SEVENTY FIVE CENTAVOS (P128,200.75) REPRESENTING THE CITY'S SHARE FOR THE INTENDED INSURANCE PREMIUMS.

WHEREAS, in his letter dated March 6, 2012, the Honorable City Mayor is requesting from this Honorable body to pass a resolution authorizing the City Treasurer to charge against the current appropriation for Other Maintenance and Operating Expenses of the City Mayor's Office, the amount of P128,200.75 representing the city's share for the intended insurance premiums;

WHEREAS, this is in line with the closing of the Book of Accounts of the General Fund for Calendar Year 2011 and the late submission of the Statement of Accounts of the Provincial Government, for the insurance premiums of barangay officials, tanods, and selected employees of the barangays, this city;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;

NOW, THEREFORE, upon motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Ma. Josefa Y. Matti, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to authorize the City Treasurer to charge against the current appropriation for Other Maintenance and Operating Expenses of the City Mayor's Office, the amount of One Hundred Twenty Eight Thousand Two Hundred Pesos and Seventy Five Centavos (P128,200.75) representing the city's share for the intended insurance premiums.
