## RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR WATER EXPENSES UNDER THE OFFICE OF THE CITY MAYOR THE AMOUNT OF TWO HUNDRED FIFTY ONE THOUSAND ONE HUNDRED SIXTY SEVEN PESOS AND FIFTEEN CENTAVOS (P251,167.15) REPRESENTING WATER BILLS FOR THE MONTH OF NOVEMBER AND DECEMBER 2011.
