RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL IN A FINANCIAL ASSISTANCE FOR BACKFILLING OF UNDERDEVELOPED PORTION OF BANTAYAN PARK IN PREPARATION FOR THE CONSTRUCTION OF THE PROPOSED ROAD IN THE AREA.

WHEREAS, in his letter dated May 2, 2012, the Honorable City Mayor is requesting for a Resolution to be passed by this Honorable body authorizing him to sign for and in behalf of the City of Bago in the Project Proposal and Memorandum of Agreement to be executed by and between the City Government of Bago and the Provincial Government of Negros Occidental in a financial assistance for backfilling of underdeveloped portion of Bantayan Park in preparation for the construction of the proposed road in the area;
