RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE NATIONAL FOOD AUTHORITY (NFA) AND THE CITY GOVERNMENT OF BAGO TO PURCHASE RICE ON CREDIT FROM NFA WHETHER TO RELIEF OPERATIONS AND FOR STOCKPILING IN PREPARATION OF EVENTUALITIES/EMERGENCIES OR FOR ITS REHABILITATION PROJECT/PROGRAM.

WHEREAS, in his letter dated May 15, 2012, the Honorable City Mayor is requesting for a Resolution to be passed by this Honorable body authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Agreement to be executed by and between the National Food Authority (NFA) and the City Government of Bago to purchase rice on credit from NFA whether for relief operations and for stockpiling in preparation of eventualities/emergencies or for its rehabilitation project/program;

WHEREAS, upon a thorough deliberation on the matter, it is the consensus of this body to grant the said request;
