RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-FIELD OFFICE VI AND THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT OFFICE IN A "SUPPLEMENTARY FEEDING PROGRAM" TO CURRENTLY ENROLLED DAY CARE CHILDREN AS PART OF THE DSWD'S CONTRIBUTION TO THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) PROGRAM OF THE GOVERNMENT.
