RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT WESTERN VISAYAS AND THE CITY GOVERNMENT OF BAGO IN A FINANCIAL ASSISTANCE FOR THE ORGANIZATION, ORIENTATION, TRAINING AND MOBILIZATION OF THE COMMUNITY HEALTH TEAM (CHT) AS PART OF THE UNIVERSAL HEALTH CARE PROGRAM OF THE DEPARTMENT OF HEALTH.
