RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN RAFAEL M. SALAS PARKS AND NATURE CENTER (RMSPNC) FOUNDATION, INC. AND THE CITY GOVERNMENT OF BAGO FOR THE JOINT UNDERTAKING FOR THE REPAIRS, RENOVATION AND REFURBISHMENT OF THE PAVILION, HEREINAFTER REFERRED TO AS THE 3Rs PROJECT.

WHEREAS, in his letter dated July 10, 2012, the Honorable City Mayor is requesting for a Resolution to be passed by this Honorable body authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between Rafael M.
