AND THE CITY GOVERNMENT OF BAGO FOR THE JOINT UNDERTAKING FOR THE REPAIRS, RENOVATION AND REFURBISHMENT OF THE PAVILION, HEREINAFTER REFERRED TO AS THE 3Rs PROJECT.**
