RESOLUTION NO. 12-148

RESOLUTION GRANTING AUTHORITY TO DR. GORGONIO T. PARROCO, COLLEGE ADMINISTRATOR, BAGO CITY COLLEGE, THIS CITY TO PRIVATELY PRACTICE HIS PROFESSION SUBJECT TO CONDITIONS SET FORTH BY THE HUMAN RESOURCE MANAGEMENT OFFICE (HRMO), THIS CITY, AND INVITING HIM TO APPEAR BEFORE THIS HONORABLE BODY DURING THE NEXT SESSION.

WHEREAS, in his letter dated July 2, 2012, the Honorable City Mayor is requesting for a Resolution to be passed by this Honorable body granting authority to Dr. Gorgonio T. Parroco, City Administrator, Bago City College, this City to privately practice his profession subject to the following conditions:

1. That his practice of profession shall not conflict nor tend to conflict with the functions of her office;
2. That his private practice of profession shall be done strictly outside of the office hours and shall not in any way interfere with the performance of her official functions and duties;
3. That the authority granted is for one (1) year subject to renewal upon the recommendation of the Honorable City Mayor;
4. That the Honorable City Mayor reserves the right to revoke the authority when the exigency of the service so demands.

WHEREAS, after a thorough deliberation on the matter, it is the consensus of this August Body to grant the same;

NOW, THEREFORE, upon motion of SP Member Bernadette M. Somcio duly seconded by SP Member Loreto N. Cauntoy, the Sanggunian

RESOLVES, as it is hereby resolved, to grant authority to Dr. Gorgonio T. Parroco, City Administrator, Bago City College, this City to privately practice his profession subject to conditions set forth by the Human Resource Management Office (HRMO), this City, and inviting him to appear before this Honorable body during the next session.
