RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE BUREAU OF SOILS AND WATER MANAGEMENT, DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT VI, PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO IN THE IMPLEMENTATION OF THE EXPANDED MODIFIED RAPID COMPOSTING (EMRC) TECHNOLOGY TO INCREASE THE PRODUCTION AS WELL AS THE INCOME OF RICE FARMERS THROUGH THE JUDICIOUS USE OF CHEMICAL FERTILIZERS IN COMBINATION WITH ORGANIC FERTILIZERS AND COMPOST FROM FARM WASTES.

WHEREAS, in his letter dated August 14, 2012, the Honorable City Mayor is requesting for a Resolution to be passed by this Honorable body authorizing him to sign for and in behalf of the City Government of Bago in the Memorandum of Agreement to be executed by and among the Bureau of Soils and Water Management, Department of Agriculture Regional Field Unit VI, Provincial Government of Negros Occidental and the City Government of Bago in the implementation of the Expanded Modified Rapid Composting (EMRC) Technology to increase the production as well as the income of rice farmers through the judicious use of chemical fertilizers in combination with organic fertilizers and compost from farm wastes;
