RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND AMONG THE CITY OF BAGO, WINNIE BAÑEZ, SALVADOR CAUNGA AND RODOLFO FAMOSO FOR A PARCEL OF LAND COVERED UNDER TRANSFER CERTIFICATE OF TITLE NO. CLOA NO. 176 WITH A TOTAL LAND AREA OF ONE HUNDRED FIFTY (150) SQUARE METERS LOCATED AT BRGY. MAILUM, THIS CITY TO BE USE FOR DAY CARE CENTER.
