**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY OF BAGO, VILLANUEVA CLINICAL LABORATORY & POLYCLINIC AND THE NEW BLOOD CHANNEL FOR THEIR SERVICES AS LICENSED CLINICAL LABORATORIES TO CATER THE LABORATORY TESTS/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENT FOR THE RENEWAL OF THE LICENSE OF THE BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.**

**WHEREAS**, in his letter dated September 11, 2012, the Honorable City Mayor is requesting for a Resolution to be passed by this Honorable body authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the City of Bago, Villanueva Clinical Laboratory & Polyclinic and The New Blood Channel for their services as Licensed Clinical Laboratories to cater the laboratory tests/examinations which are not available at the Bago City Hospital Laboratory as a requirement for the renewal of the license of the Bago City Hospital with the Department of Health;
