RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION OF A PORTION OF REAL PROPERTY TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BUREAU OF FIRE PROTECTION (BFP) FOR THE DONATION OF A PORTION OF REAL PROPERTY COVERED UNDER TRANSFER CERTIFICATE OF TITLE NO. T-38342 CONTAINING AN AREA OF ONE THOUSAND ONE HUNDRED THIRTY EIGHT (1,138) SQUARE METERS, MORE OR LESS.

WHEREAS, in a letter dated September 4, 2012 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in the Deed of Donation of a Portion of Real Property to be executed by and between the City Government of Bago and Bureau of Fire protection (BFP) for the donation of a portion of real property covered under Transfer Certificate of Title No. T-38342 containing an area of One Thousand One Hundred Thirty Eight (1,138) Square Meters, more or less;

WHEREAS, the Deed of Donation of a Portion of Real Property of about Four Hundred Sixty Five (465) square meters of the above-described parcel of land is for the Office of the Bureau of Fire Protection, Bago City;
