RESOLUTION ENDORSING THE “POVERTY ALLEVIATION THROUGH SOLUTIONS TO FOOD SECURITY PROGRAM” OF THE CITY AND REQUESTING A TEN MILLION PESOS (P10,000,000.00) FUNDING FROM THE DEPARTMENT OF AGRICULTURE FOR THE PREPARATION OF THE PROGRAM.

WHEREAS, in line with the Department of Agriculture’s National Rice Program, the City is launching a “Poverty Alleviation Through Solutions to Food Security Program”;

WHEREAS, this is part of the continuing efforts of the local government in establishing economically sustainable community and people in the City;

WHEREAS, the program will develop two thousand (2,000) hectares of irrigated rice land;

WHEREAS, the program seeks to establish eight (8) production entities of two hundred fifty (250) hectares each;

WHEREAS, the program also seeks to establish a single seed production component.

NOW, THEREFORE, upon motion of SP Member Loreto N. Cauntoy, duly seconded by SP Member Bernadette M. Somcio, the Sanggunian

RESOLVES, as it is hereby resolved to endorse the City’s “Poverty Alleviation Through Solutions to Food Security Program” and requesting the Department of Agriculture for a Ten Million Pesos (P10,000,000.00) Funding for the preparation of the program.
