**RESOLUTION NO. 12-204**

**RESOLUTION DISAPPROVING THE REQUEST OF MS. ERVILYN DAGUMANPAN FOR AN ENDORSEMENT OF HER INDUSTRIAL SAND AND GRAVEL PROJECT LOCATED AT BARANGAY ATIPULUAN, THIS CITY.**

**WHEREAS**, in an endorsement dated September 25, 2012 from the Honorable City Mayor Ramon D. Torres, addressed to this body, is a referral of the request of Ms. Ervilyn Dagumanpan, for a resolution to be passed by this body favorably endorsing her industrial sand and gravel project located at Barangay Atipuluan, this city;

**WHEREAS**, this matter was referred to the Committee on Environmental Protection and after a thorough deliberation on the matter, it is the consensus of this body to disapprove the said request due to the following reasons, to wit:

1. Ms. Ervilyn Dagumanpan submitted an erroneous vicinity map in which portion of the applied area, specifically the riverbed belongs to her mother-in-law, Mrs. Teresita Dagumanpan who is another permit holder which during her previous operation was penalized by the Provincial Environment Management Office (PEMO) and was issued a Cease and Desist Order (CDO).
2. The area of Mrs. Teresita Dagumanpan was already depleted and was advised to rest the area for a while as pointed out by Mr. Madalag of PEMO.
3. The other portion, the upland area is under coverage of the Comprehensive Agrarian Reform Program (CARP) and therefore closed to Mining under Executive Order No. 79.

**NOW, THEREFORE**, upon motion of SP Member Donald A. Alvarez, duly seconded by SP Member Loreto N. Cauntoy, the Sanggunian

**RESOLVED**, as it is hereby resolves, to disapprove the request of Ms. Ervilyn Dagumanpan for an endorsement of her industrial sand and gravel project located at Barangay Atipuluan, this city.
