RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND BAGO CITY COLLEGE FOR A SCHOLARSHIP GRANT TO POOR AND DESERVING STUDENTS IN THE PROVINCE OF NEGROS OCCIDENTAL.

WHEREAS, in his letter dated November 13, 2012, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City Government in the Memorandum of Agreement to be executed by and between the Provincial Government of Negros Occidental and Bago City College for a Scholarship Grant to poor and deserving students in the Province of Negros Occidental;
