RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BAGOSPHERE PH INC. FOR THE CONSTRUCTION OF THE TRAINING CENTER IN BAGO CITY FOR THE TRAINING OF OUT-OF-SCHOOL YOUTH OF THE CITY FOR POSSIBLE EMPLOYMENT AT BUSINESS PROCESS OUTSOURCING (BPO) COMPANIES.
