**RESOLUTION AUTHORIZING THE GRANT OF INCENTIVE ALLOWANCE AT ONE THOUSAND PESOS (P1,000.00) EACH TO 198 BARANGAY HEALTH WORKERS (BHW), 48 BARANGAY NUTRITION SCHOLARS AND 80 BARANGAY DAY CARE WORKERS. THE TOTAL AMOUNT OF THREE HUNDRED TWENTY SIX THOUSAND PESOS (P326,000.00) CHARGEABLE AGAINST THE APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES (969) OF THE OFFICE OF THE CITY MAYOR GENERAL FUND FOR CALENDAR YEAR 2012.**

**WHEREAS**, in his letter dated December 11, 2012, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing the grant of Incentive Allowance at One Thousand Pesos (P1,000.00) each to 198 Barangay Health Workers (BHW), 48 Barangay Nutrition Scholars and 80 Barangay Day Care Workers;
