RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND ENERGY DEVELOPMENT CORPORATION IN THE CONDUCT OF SKILLS ENHANCEMENT TRAINING ON SMAW NC II AND BAG MAKING IN LINE WITH THE EDC'S CORPORATE SOCIAL RESPONSIBILITY PROGRAM TO PROMOTE LIVELIHOOD PROSPERITY OF THE HOST COMMUNITIES THROUGH A COMPREHENSIVE LIVELIHOOD PROGRAM IN PARTNERSHIP WITH ITS STAKEHOLDERS.
