RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF SERVICE TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND MAGIC DISCO SOUND SYSTEM FOR THEIR SERVICES OF THREE (3) UNITS LIGHTS AND SOUND SYSTEM, ONE (1) UNIT GENERATING SET 162KVA, SILENT TYPE, IN CONNECTION WITH THE 5^{TH} LIGHTS OF BAGO ON JANUARY 1, 2013.
