**RESOLUTION URGENTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-REGIONAL OFFICE NO. VI, ILOILO CITY TO ADD ANOTHER WEIGHBRIDGE LOCATED AT THE SOUTHEND OF BAGO BRIDGE GOING TO BACOLOD CITY, NEGROS OCCIDENTAL.**

**WHEREAS**, the Bago Bridge is almost 30 years already and it can no longer cater to heavy vehicles that pass by the bridge so therefore another weighbridge must be installed in order to minimize the load that vehicles may carry in passing the Bago bridge in order to secure it against future damage due to overloading;

**NOW, THEREFORE**, upon motion of SP Member Allan C. Galunan, unanimously seconded by SP Members present, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved, to urgently request the Department of Public Works and Highways-Regional Officer No. VI, Iloilo City to add another weighbridge located at the southend of Bago bridge going to Bacolod City, Negros Occidental.
