## **RESOLUTION NO. 13-044**

RESOLUTION APPROVING THE REPROGRAMMING OF FIVE MILLION PESOS (PHP5,000,000.00) FROM THE UNEXPENDED APPROPRIATIONS FOR THE RESTORATION OF CULTURAL OR HISTORICAL SITES (2012-20% DEVELOPMENT FUND) TO (1) THE CONSTRUCTION/REHABILITATION OF LOCAL ROADS OR BRIDGES AND PURCHASE OF APPROPRIATE ENGINEERING EQUIPMENT SUCH AS, BUT NOT LIMITED TO, DUMP TRUCKS, GRADERS, PAYLOADERS – PHP4,100,000.00 AND (2) OTHER PROJECTS THAT CONTRIBUTE TO THE ATTAINMENT OF ECONOMIC DEVELOPMENT – PHP900,000.00 AND ALSO APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF THE CITY FOR CALENDAR YEAR 2013.

WHEREAS, in a letter dated January 28, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a Resolution approving the reprogramming of Five Million Pesos (PhP5,000,000.00) from the Unexpended Appropriations for the Restoration of Cultural or Historical Sites (2012-20% Development Fund) to (1) The Construction/Rehabilitation of Local Roads or Bridges and Purchase of Appropriate Engineering Equipment such as, But Not Limited to, Dump Trucks, Graders, Payloaders – PhP4,100,000.00 and (2) Other Projects that Contribute to the Attainment of Economic Development – PhP900,000.00 and also approving the Supplemental Annual Investment Plan of the City for Calendar Year 2013;
