RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE RFU-VI AND THE CITY GOVERNMENT OF BAGO FOR THE FINANCIAL ASSISTANCE AMOUNTING TO TWENTY THREE MILLION SIX HUNDRED THOUSAND (PHP23,600,000.00) PURPOSELY FOR THE IMPLEMENTATION OF VARIOUS AGRICULTURAL DEVELOPMENT PROGRAMS OF THE CITY.
