RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) – FIELD OFFICE VI, PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE AND THE CITY GOVERNMENT OF BAGO FOR A SUPPLEMENTARY FEEDING PROGRAM TO CURRENTLY ENROLLED DAY CARE CHILDREN AS CONTRIBUTION TO THE EARLY CHILDHOOD CARE AND DEVELOPMENT PROGRAM OF THE GOVERNMENT.
