**RESOLUTION NO. 13-063**

**RESOLUTION SUPPORTING REPUBLIC ACT NO. 7719 OTHERWISE KNOWN AS “AN ACT PROMOTING VOLUNTARY BLOOD DONATION, PROVIDING FOR AN ADEQUATE SUPPLY OF SAFE BLOOD, REGULATING BLOOD BANKS AND PROVIDING PENALTIES FOR VIOLATION THEREOF”.**

**WHEREAS**, Section 15 of the 1987 Constitution of the Republic of the Philippines provides that “the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, after a thorough deliberation on the matter, this August body is of the consensus to support Republic Act No. 7719 otherwise known as “An Act Promoting Voluntary Blood Donation, Providing for an Adequate Supply of Blood, Regulating Blood Banks and Providing Penalties for Violation Thereof”;

**NOW, THEREFORE**, upon motion of SP Member Noel T. Valenzuela, duly seconded by SP Member Allan C. Galunan, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved to support Republic Act No. 7719 otherwise known as “An Act Promoting Voluntary Blood Donation, Providing for an Adequate Supply of Blood, Regulating Blood Banks and Providing Penalties for Violation Thereof”.
