RESOLUTION REQUESTING THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE TWO (2) UNITS OF AMBULANCE ON A COST-SHARING SCHEME TO BE USED BY THE CITY DISASTER REDUCTION AND MANAGEMENT OFFICE, THIS CITY IN RESPONDING TO EMERGENCIES CAUSED BY NATURAL AND MAN-MADE CALAMITIES AND THE CITY HEALTH OFFICE, ALSO OF THIS CITY AS SERVICE VEHICLE TO ENSURE AVAILABILITY OF TRANSPORTATION DURING EMERGENCIES AND OTHER MEDICAL SERVICES.
