**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND ROEST MARKETING FOR PROVIDING THE CITY THROUGH THE CITY HEALTH OFFICE THIRTY (30) UNITS OF GLUCOMETER MACHINE (GALAXY G-26 BRAND) WITHOUT ANY COST ON THE PART OF THE CITY GOVERNMENT IN THE ACQUISITION OF THE MACHINE.**

**WHEREAS**, in a letter dated March 19, 2013 from Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Roest Marketing for providing the City through the City Health Office Thirty (30) Units of Glucometer Machine (Galaxy G-26 Brand) without any cost on the part of the City Government in the acquisition of the machine;
