RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF SOUTHBAY SUBDIVISION PHASE 2 WITH HOUSING COMPONENT, SITUATED AT BARANGAY SAMPINIT, THIS CITY, CONTAINING A TOTAL AREA OF FIFTY FOUR THOUSAND THREE HUNDRED SIXTY SEVEN (54,367) SQUARE METERS INTO THREE HUNDRED FIFTY THREE (353) SUBLOTS.

WHEREAS, in an endorsement letter dated March 18, 2013 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Deny L. Millevo, Zoning Officer II-Designate, for approval, the application for Preliminary Approval and Locational Clearance of Southbay Subdivision Phase 2 with Housing Component, situated at Barangay Sampinit, this City, containing a total area of Fifty Four Thousand Three Hundred Sixty Seven (54,367) Square Meters into Three Hundred Fifty Three (353) Sublots;
